

## Completion of Share Placement

Alicanto Minerals Ltd (ASX: AQI) ("Alicanto" or "the Company") is pleased to announce that it has successfully completed a share placement ("Placement") to raise \$1.0m with the allotment of 13.99 million shares at \$0.075 each. The funds raised from the Placement will be used to advance additional opportunities within Guyana and for working capital purposes.

Under the Placement, Alicanto has issued a total of 13.99 million new shares at a price of \$0.075 per share pursuant to ASX Listing Rule 7.1 (8.23 million) and 7.1A (5.76 million).

Attached is the Appendix 3B in relation to the Placement.

### Information required under ASX Listing Rule 3.10.5A

Alicanto provides the information as required under ASX Listing Rule 3.10.5A as follows:

- a) Dilution to existing shareholders as a result of the issue under Listing Rule 7.1A is 9.1%, dilution to existing shareholders as a result of the issue under Listing Rule 7.1 is 13.0% and the total dilution to existing shareholders as a result of the placement is 20.0%.

Further details of the approximate percentage of the issued capital post the 7.1A placement (5.76 million shares) held by the pre-placement security holders and new security holders are as follows:

Pre-placement security holders who did not participate in the placement	54%
Pre-placement security holders who did participate	32%
Participants in the placement who were not previously security holders	14%

- b) Alicanto issued shares to sophisticated investors as it was considered to be a more efficient mechanism for raising the funds for the current placement. The placement did not expose the Company to market volatility that may have been experienced over a more protracted raising process such as a pro-rata issue;
- c) No underwriting arrangements were in place for the placement; and
- d) Total fees payable on the total funds raised was \$20,000.



### Notice under Section 708A

Alicanto issued 13,990,600 shares on 14 March 2016 to sophisticated investors to raise gross proceeds of \$1,049,295. A further 416,650 shares have also been issued to management in lieu of salary. The securities are part of a class of securities quoted on the Australian Securities Exchange Limited (ASX).

The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act. The shares were issued without disclosure to the various parties under Part 6D.2, in reliance on Section 708A(5) of the Corporations Act. The Company, as at the date of this notice, has complied with:
